4. Contestant is ineligible if arrested and convicted of any crime.
5. The Citrus County Fair Association reserves the right to reject or accept any contestant.
6. Contestants under the age of 18 who do not have their own transportation must have Parent or Guardian's written consent listing person(s) eligible to transport contestant.
7. The decisions of the judges are final and are verified by certified public accountant.
